Orangewood Condominium Association Inc. RULES AND REGULATIONS

Please initial on the line provided to the left of each regulation to verify acknowledgement to the terms.

1.	No owner or tenant shall occupy a unit until the Board has acted upon the application submitted.
2.	All restrictions contained in Article IX of the Condominium Declaration, hereto attached, are to apply. In addition, all tenants and their guests must comply with the following Rules and Regulations, and the Board reserves the right to terminate a lease and evict any tenant violating any provision of these.
3.	All sales and rentals are subject to the approval of the Board of Directors. Applications will be submitted on a form approved by the Board, will be signed by the applicant(s) and unit owner personally, and not by his or her agent, and will be accompanied by a signed receipt of a copy of the Association's Rules and Regulations, together with a copy of any proposed lease. MONTHLY MAINTENANCE FEES ON THE UNIT MUST BE CURRENT PRIOR TO BOARD APPROVAL OF A SALE OR LEASE. Monthly dues can be included in sale contract to be paid at closing, including late fees.
3a.	All sales and lease applications must be accompanied by a \$100 NON-REFUNDABLE PROCESSING FEE FOR EACH APPLICANT, other than husband/wife, or parent/dependent child.
3b.	An investigative background inquiry will be performed on all sales applicants. The appropriate authorization form will become an attachment to the sales application.
4.	Applications will be acted upon within TEN (10) DAYS from the date of submission to the Board and will be approved or disapproved by two members of the Board and/or one Board Member and Condominium Manager.
5.	No more than two (2) leases per calendar year are permitted and NO sub-lease or assignment of a lease shall be made by a unit owner or tenant. Leasing or renting of a unit by an owner (directly or through an agent), for a period less than sixty (60) days is prohibited.
6.	NO MORE THAN FOUR PERSONS SHALL OCCUPY A UNIT. A guest occupying a unit for more than two weeks shall be deemed to be a permanent occupant. No change in the names or number of occupants as set forth in the original application is permitted without the prior approval of the Board.
7.	All owners and tenants must abide by all Charlotte County Laws, Florida Statutes, and no pets, other animals, hot tubs, spas or waterbeds are allowed in a unit or common area.
8.	The use of the pool is restricted to owners and tenants occupying a unit. Children under the age of 16 years must be accompanied by an adult resident, and no visitors will be permitted in the pool area unless accompanied by a resident. The pool is to be utilized only during the hours between Dawn and Dusk.
9.	Parking spaces are limited common elements and are available for the use of unit owners, and tenants. One parking space is assigned to each unit, and additional spaces are provided for guest parking and/or a second car. Only two cars per unit are permitted. Motor homes and vehicles with identification inscribed thereon are prohibited, as are recreational vehicles. All vehicles shall be in good running condition and properly licensed. Unit owners or tenants shall not store a motor vehicle in the parking areas, or occupy a space assigned to another unit. All vehicles must park head in to display license plates at all times. Any violation of the parking rules, after due notice to the owner or tenant; will subject the vehicle to immediate towing at the car owner's expense.
10.	Discarded items too large for the dumpster must be discarded by the owner or tenant. Contact local Governmental Agencies for proper disposal procedures. COST IS TO BE BORNE BY THE OWNER OR TENANT.
11.	No laundry or other material is to be hung on the exterior of the building or in a common area. Use of laundry facilities is restricted to owners/tenants residing in a unit.
12.	No bicycle riding, skates, skateboards or tricycles allowed on the Orangewood Condominium sidewalks.
13.	Unit owners are responsible for the conduct of real estate agents or brokers employed by them, and have a duty to ensure that any such agent or broker is provided with a copy of the rules and regulations adopted by the Board of Directors, as well as a copy of the application form currently in use.

Article IX of the Declaration of Condominium for Orangewood Condominium Association, Inc. provides for certain use restrictions, as follows:

In order to provide for a congenial occupation of the condominium and to provide for the protection of the value of the units, the use of the property shall be restricted to and be in accordance with the following provisions:

- A. The units shall be used for single family residences only and maintained in a clean and sanitary manner.
- B. The common elements shall be used to the furnishing of services and facilities for which they are reasonably intended, for the enjoyment of the unit owners, and subject to such regulation by rules and By-laws as may in the opinion of the condominium association achieve the maximum beneficial use thereof.
- C. Nuisances. No nuisances shall be allowed upon the condominium property nor any use or practice that is the source of annoyance to residents or which interferes with the peaceful possession and proper use of the property by its residents. All parts of the condominium shall be kept in a clean and sanitary condition, and no rubbish, refuse or garbage allowed to accumulate nor any fire hazard allowed to exist. No unit owner shall permit any use of his unit or make any use of the common elements that will increase the cost of insurance upon the condominium property.
- D. Lawful use. No immoral, improper, offensive or unlawful use shall be made of the condominium property or any part of it; and all valid laws, zoning ordinances and regulations of all governmental bodies having jurisdiction shall be observed. The responsibility of meeting the requirements of governmental bodies for maintenance, modification or repair of the condominium property shall be the same as the responsibility for the maintenance and repair of the property concerned.
- E. Signs. No "For Sale" or "For Rent" signs or other signs shall be displayed by any individual unit owner on his condominium parcel, or any part of the condominium property, nor shall any external television or radio antennas be erected upon or fixed to the condominium property or unit house except as provided under uniform regulations established from time to time by the association.
- F. Pets. No pets or other animals may be kept in units and allowed on the common property unless authorized by regulations established by the Association.
- G. Leasing. An entire unit may be rented provided the occupancy is only the lessee and his family, his servants and guests. No rooms may be rented except as a part of a unit or to another unit owner; and no transient tenants may be accommodated. The Board shall have the right to approve all leases.
- H. Guests. All guests and tenants must comply with the Association regulations and the Board shall have the right to terminate a lease and evict a tenant who fails to comply with the regulations of the Association.
